AAHOA to Testify at Rally on New York City Council's Proposed Safe Hotels Act

ATLANTA, GA, September 10, 2024—AAHOA (Asian American Hotel Owners Association) will join other industry associations and companies in opposing the proposed <u>Safe Hotels Act</u> at a rally at 9 a.m. EDT on Thursday, September 12, at New York City Hall. If passed, this act would prohibit hotels from operating without an additional license and prohibit using subcontractors for core functions such as housekeeping, front desk, and security.
